Daniel D. Curry:

A little over a year ago we responded to your joke of a “cease and desist” letter. What damages *have* CCPS assessed? When *are* you going to sue us? Please, go for it. CCPS sure hasn’t improved in the last year, and you can’t blame COVID for your and others’ sickening abuse, ineptitude and incompetence. This time last year no one could have anticipated the impacts of COVID, and the year has been draining and traumatizing for so many. What have you, in your role as superintendent, done to *actually* help? Why are you still the Superintendent? Dawn Balinski won reelection, which was an absolute travesty. It would have been so nice for the simpering rube to have been replaced by someone who wouldn’t prop up and support a sadistic pedophile like yourself. One thing we should all know – no matter how pleasant and outwardly substantial, people like Dawn Balinski have few to no ethics and will go with prevailing wind. She doesn’t even seem to know or care what she thinks or says from one moment to the next and will throw you over as she faces “the fire.” It won’t matter, and she’s going to wish she hadn’t run for reelection. What have you done for the people you were hired to educate and protect, over the last year, or ever?

Let’s see. You threw a “hissy fit” to try to force at the last minute the return of Pre-K through 2nd graders to the system, which is on the older side of your predilections, but still within your preferred range of boys. Your second wife, Jacqueline Wisnaukas, who teaches 1st grade at Patuxent Appeal Elementary, has been all too eager to help. Don’t pretend either you or she care about people, and don’t pretend you care about her; otherwise, you wouldn’t have tried to force the return of younger students so she might be impacted. You have not helped educators and other staff remain safe, and they have been periodically forced back to work without proper safeguards for themselves or students. Contact reporting has been discouraged. You know good and well students from homes where parents are desperate to work to keep food on the table or who just don’t want their kids around will be the ones most likely to need or want to return them to school. Disabled students and students of color factor prominently among them. They are also the kids most likely to be susceptible to abuse. Not incidentally, complicit Board members were the ones most interested in pretending CCPS was prepared to handle COVID, even though they knew for years what you are and what is happening. Maybe you and your mistress-wife Jacque can read this and tear out each other’s throats in fear. The Calvert County Commission, Sheriff Mike Evans, CCPS Board of Education and so many others have also *known* this – but, what have they done? Why does Calvert County have so many good people in it, with leaders like the majority of the preceding running the show? When are people other than spineless

cowards *going* to be the majority running the show? How many people wish to be exposed for knowing for so many years about serial sexual and all corresponding and resulting abuses running rampant? How many have been complicit and how many have participated?

But, although CCPS has had a mandate for online learning protocols since 2017, the rollout has been appalling. We are not disparaging most of CCPS' IT department – what are they supposed to do? IT Program Coordinator Joel Parmer has clearly helped keep CCPS running, but you used him as your fall guy when IT Director McClellan couldn't and wouldn't perpetuate any more lies to protect you. *What* do you allow them to do? You made sure all kids have computers, even the kids who don't need them. Problem is, it is nearly impossible to roll out internet access safeguards from a central level. What did CCPS do to alleviate that? Have there been warnings, let alone guidelines for parents to install and implement protections? Does unfettered access to anything for any child feed your perversions? Is that why nothing has been done? Have you made sure *staff* have all equipment they need to fulfill what you require of them? Of course not, but they are run more ragged all the time trying to keep up.

You did make sure to address racism in this time of desperation, because of all things, racism and equity matter to you. Racism distracts from COVID, which disproportionately affects people of color? Is your “white entitlement” the reason for your sadism, misogyny and pedophilic tendencies? When recent Calvert High principal Steve Lucas left to become Superintendent of Lake Forest, DE (your last Superintendent position) there was a disgusting exhibition of racism and white entitlement to welcome the new black principal, on the field at Calvert High. It was an evil, stupid display and those young men deserved charges beyond what they received. You weren't bothered by it, except for how it reflected on you, but you and others, including Dawn Balinski and Tracy McGuire, did exploit the incident to *pretend* you care. You want to talk about “white privilege?” Does your white privilege make you, or them, what all of you are? Maybe, but only in small part. How dare you, and how dare anyone else not see it only as an excuse to pretend equality matters to you and distract from the truth? How dare anyone - including Board members Pamela Cousins and Inez Clagett - focus on such an important issue as a root cause when more pressing issues must first be addressed? So many educators and other staff in CCPS are not racist and care so much. You do not permit them to address racism where and when it exists. Plenty of kids – and a few educators – are racists. The racists are not going away, but it is the example you set, support and encourage. Since you pretend you don't know, racism – like poverty - is generational, and bigotry should be taken for granted. *Education* overcomes, but you have never been a true educator. You encourage racism to facilitate your pedophilic and sadistic goals. You don't care – you target kids of color, knowing they are sometimes easier. There should be total intolerance for discrimination, and education to enlighten people who may or may not be willing to understand the pointlessness of the pain and magnitude of the damage, but in CCPS the n-word is regularly hurled and racism across the board ignored. “Implicit bias” is important too, but even lower on the list. How to fix this mess? Does CCPS need to implement policies against pedophilia and sadism? Does CCPS need a policy mandating basic decency? Of course not, and for all the good policy changes have so far made, why would they matter? There weren't already laws and policies prohibiting racism? You still blame others to distract from the larger problems which allow networked pedophilia to flourish. Pedophilic abuse is the principal motivation.

How to expose the abuse? The emails and financials will begin to tell us. They will tell everyone. Our requests will continue to roll in, and when we finally obtain the records the County will be exposed. In turn, other places then will be. This is a far larger problem than only in Calvert County and it should not

be regarded as unique or reflective of the people of Calvert County as a whole; in fact, it should be taken for granted there are many potentially worse areas, districts and municipalities, all around the country. People need to know what is happening in their communities, so far beyond what any decent person could easily imagine. Decent people don't automatically think this way; it takes awareness and time. We are sending in new PIA requests and have made some serious progress with around 6 years of vendor reports. You continue to claim there are no funds other than 1, 3, and 5, we have more than enough to prove that isn't true and proof of over well over \$100 million in expenditures over a span of about six years, made from supposedly nonexistent accounts/funds. Over a two-year period CCPS paid around \$25 million for redundant *mail-away* prescription coverage, even though staff already have prescription coverage through BCBS, and local pharmacies and BCBS coordinate mail-away services. What *is* going on with the local mail, including ours? Why did you lie about the existence of ledgers for unrestricted expenditures from funds held separate from the General Fund in Phase 1 of our PIA suit? Where *does* CCPS get the money? Has CCPS always spent federal funds as mandated? Why did Tracy McGuire announce in September 2019 she is not running again, due to "term limits?" I sent in a new request a while back for a few expenditures for her husband, John G. McGuire, who works for CCPS in IT, as a "Data Processing Manager." They're probably legitimate expenditures/reimbursements, but it's clear the McGuires are worried about something. How deep and how far does the corruption go? Our requests will continue to mount. In the meantime, how can you justify the estimates for so many of our outstanding requests, including \$59,241-\$118,482 for around 6 years of banking and investment statements, and Student Activity Funds? What are you going to do to solve the looming problems you face? How many lawsuits will you and anyone who explicitly or tacitly supports you continue to invite?

We want the missing expenditure ledgers for the following accounts, which you said do not exist in Phase 1 of our PIA suit. From where do you expend tens of millions a year, beyond and separate from what we possess of Funds 1, 3 and 5? Here are the account numbers, at a minimum, which will be contained in the ledgers we want: (don't forget – they are unrestricted ledger expenditures by or for executive staff, including you, which in Phase 1 you stated didn't exist).


