Daniel D. Curry:

We received "Ms. Maxey's" estimates for our 1/15, 1/22 and 1/27 PIA requests, as well as "her" response to our 2/01 request. We'll get to those, but first, your 1/28 budget presentation didn't include a budget. Why did you waste everyone's time? A PowerPoint suffices for a budget? Couldn't you have cancelled and rescheduled the meeting when you finally have the budget ready to present? What are you hiding? Why didn't you address CCPS' outrageous healthcare costs and double prescription coverage like we specifically asked? Why didn't you address any of the other Public Comment questions? Why weren't you prepared? When is the Board going to start mouthing off and laying you out for the evil, worthless monster you are?

- 1/15 - Request for 285 invoices and copies of 68 checks/payments/vouchers for Kennedy Krieger, and 1 invoice and 1 payment/check/voucher for Kajeet Inc.

O The estimate of 85 hours at 45.50/hr., for a total cost of \$3776.50 with a \$1750 deposit is ludicrous. Before 2 hours are waived, that means the total cost for these records is supposedly \$3,867.50. In all likelihood these records will total 355 pages. That means each page would cost ~\$10.89 and a little over 4 pages can be produced an hour.

On 9/20 I requested 84 POs for Kennedy Krieger. The cost estimate was for 4 hours, with a total cost of \$83.44. No hourly rate was mentioned. Before 2 hours are waived that would be \$166.88. That means each PO for Kennedy Krieger would cost \$1.99 to produce and 21 pages can be produced per hour. Why so much less for the POs than the invoices and payments we requested on 1/15, which pertain to the same transactions?

O Something to consider: many, if not all, of these records will require redaction, whereas many of the other requests we have made for POs, invoices and check/voucher/payments do not. Under that logic, why would it supposedly cost about as much for each of these records as it would for those?

O We have already stated we worry kickbacks might be involved with some services, although we would never begrudge any child services to which they are entitled, deserve and need. Is that why CCPS has paid such outrageous sums to Kennedy Krieger? Do you worry about the possibility of kickbacks?

- 1/22 8 POs and 3 sets apiece of invoices and copies of payments/checks/vouchers for Kev Software and Kingdom Ventures, and 64 invoices and 56 copies of checks/payments/vouchers for the Lab School of Washington.
 - o The 02/02 estimate of 22.5 hours at \$45.50/hr., for a total cost of \$932.75, with a deposit of \$500 is ludicrous. Before 2 hours are waived, that means the total for these records is supposedly \$1023.75. In all likelihood these records will total 140 pages. That comes to ~\$7.31/pg. and a little over 6 pages can be produced an hour.
 - Kev Software products help with Student Activity fee management. These records might tie into our 8/01/20 request for banking and investment statements which will include Student Activity Funds. CCPS' auditors Clifton Larson Allen made particular reference to SAFs in December of '19, and we were estimated around \$60-\$120k for that request.
 - Kingdom Ventures is a consulting firm which provided program evaluations for the Judy Center at Patuxent Appeal Elementary, which is the most dangerous and violent elementary school in the County. Your wife, Jacqueline Wisnauskas, who was your At-Risk Youth Director when you were married to your first wife, teaches first grade there. Anthony Barone was appointed from Vice Principal at Calvert High's CTA to Principal at PAC, at your improperly advertised 6/24/19 closed-door Superintendent's evaluation. My son took a drafting/engineering course at the CTA and we know he was not safe to remain in the system. There is absolutely no reason to think Kingdom Ventures is anything less than reputable and they appear to provide a quality service. Judy Centers, named for U.S. Representative Steny Hoyer's late wife, are often, if not always, located at or near Head Start schools like Patuxent Appeal, and we know they provide many valuable services to the communities they serve. Although we in no way think they are at all a part of your revolting network and would never deliberately do anything to facilitate it, that Judy Center is an attractive device to families who may need their services, including children who may be more susceptible to sexual abuse due to their families being stretched thin. What do you think Rep. Hoyer might think to know the educational nonprofit established in his wife's memory is being in any way exploited to facilitate yours and others' sick perversions?
 - We would never begrudge any child services to which they are entitled, deserve and need, but still have plenty of questions surrounding all of CCPS' out-of-county and nonpublic tuition expenditures, like for the Lab School of Washington.
 - 1/27 Request for 9 POs, 1 invoice and check/payment/voucher apiece for the Law Offices of Mark B. Martin and Law Offices of Brian Gruber, 22 invoices and 22 checks/payments/vouchers for Law's Speech Stars and 5 invoices and 5 checks/payments/vouchers for Lighthouse Services.
 - o The 02/02 estimate of 8 hours at \$45.50/hr., for a total cost of \$273 with a \$150 deposit is ludicrous. Before 2 hours are waived, that means the total for these records is supposedly \$364. In all likelihood these records will total 67 pages. That comes to ~\$5.43/pg. and a little over 8 pages supposedly can be produced an hour.
 - You, others of your ilk and countless malicious educators like those at Southern Middle who participated in a campaign of ostracism to hurt my daughter, after we complained about circumstances surrounding what we now know was related to Travis Mister's pedophilia, invite liability all the time. We'd like to know more about the payments to Mr. Martin and Gruber's firms.

- There is absolutely no reason to think Kingdom Ventures is anything less than reputable and they appear to provide a quality service. However, there are accounting anomalies in CCPS expenditure documentation we possess.
- CCPS pays Lighthouse Services to provide compliance and whistleblower hotlines.
 Since you only care about obtaining information to manipulate and hurt people, we'd like to know more about those.
- 02/01 Request for "Any and all monthly/quarterly/annual rolls/lists of insured for members enrolled in each of the CCPS BCBS insurance plans listed below, from 01/01/17 until the date they are provided."

o The 02/03 response that these records are exempt from disclosure makes as much sense as when you tried it on 10/16/20, when we requested lists/rolls for insured members for CCPS' Keenan and Associates/Express Scripts double prescription coverage. Again, we are not asking for private and protected medical information, nor other protected personnel information, nor any of Staff's personal financial information. These rolls/lists pertain to *compensation*, of which insurance is part. We look forward to receiving these records.

So far, we are halfway through the alphabet of vendors for PO, invoice and check/payment/voucher requests, and then we will begin to focus on bus contractor expenditures, in preparation for Phase 2. As you have steadfastly refused to allow Records Custodian Karen Maxey and any staff who may help her to do their jobs, and will not provide records to which we are entitled for reasonable fees, if at all, we will pursue them then. As for refusing to provide lists of rolls for CCPS' myriad insurance programs, something bad is going on with those. Since you have refused to provide those records, and chose not to address healthcare costs at your non-budget annual budget presentation, we feel no choice but to write a letter to Sheriff Mike Evans, asking him to stand up for the community he was elected to represent by opening an investigation into these matters, as well as pedophilia in the system, with the hope he will be willing to fully apprise Calvert County of what those investigations reveal.
