Daniel D. Curry:


June 2<sup>nd</sup> is coming up soon. We are prepared, in protest, to pay the outrageous fees you have assessed for the financial records we have requested, although we should not have to, and we have no idea why the Board allows you to continue to invite such liability and create so much difficulty for CCPS.

According to *your* estimate for the financial records we requested on 5/17/20, we should pay \$677.02 for records, entirely upfront, before we will receive them (with \$350 waived). You suddenly care about protecting vendor privacy even though you do not care about staff privacy, and wish to charge for contacting vendors for an IDIQ bid, which they have no way of contesting. How much sense does that make? Your estimate for our 06/02/20 emails records request is arbitrary. How can we pay in entirety, upfront, for records when you have provided a *range* of what the records might cost? You need to decide what those costs will be, and then we will pay them at the same time we pay for the financial records.

We reiterate our desire to pay reasonable fees for records, but you continue to alter CCPS' fee structure to obfuscate and try to limit our access to records. We want the financial records to be provided via email, only in native/unaltered format. We want the emails to be provided as we requested, on a flash drive, in the PST format you offered, and for all emails which require redaction to be printed and *properly* redacted. The email searches must be conducted in Gaggle, for the full range of time we requested, and we require a native format/unaltered count sheet. We have already disproven your arguments that o365 is necessary to perform the searches, and your IT Director informed us two years ago Gaggle is the appropriate search method to use for that range of time. We will not accept piecemeal responses to our requests. You have spent enough time violating the law and CCPS policy, and continue to use and betray staff to do it.

So, how much do we owe, and when will the records be ready?
