Daniel D. Curry:

We received "Ms. Maxey's" 11/24 responses to our 10/21, 10/23, 10/26, 10/28, 11/04, 11/06, 11/16, 11/18, 11/19 modification and 11/20 PIA requests. Your responses make no sense, but your inconsistency and hypocrisy know no bounds. I'll go in order, not to mention we still have other incomplete/outstanding records requests, and will be submitting more.

- 1. 10/21 for 25 "SET UP FY19 7000" transactions
 - a. eFinance Expenditure Budget Records (produced including any relevant "Advanced" search features);
 - b. full Transaction Pages used to search for and display all transactions associated with the Expenditure Budget Records; and,
 - c. all Transaction Detail pages
 - I fail to see how the request is "vague and ambiguous." That's okay we will receive the records in Phase 2 of our PIA suit.
- 2. 10/23 10 POs and invoices and checks/vouchers/payments for 25 transactions, many of which can be printed directly from eFinance, and will supposedly require 7.5 hours to produce, at a total cost of \$250.25 (\$45.50/hr.) That is preposterous, and we will pursue these records in Phase 2. I have already pointed out to you we were provided much larger batches of similar records easily and for free.
- 3. 10/26 eFinance reports
 - a. All eFinance Revenue Ledger Short Listing reports from Pd. 1 of FY15 through the date the report/s are run, to include all 13th month accounting periods.
 - b. All eFinance Revenue Audit Trail reports from Pd. 1 of FY15 through the date the report/s are run, to include all 13th month accounting periods.
 - A cursory look shows these appear to have been provided in full, for free. Thank you. Why did it take a month to provide a lousy 14 eFinance reports which require no redaction? Your explanation of "Fund 7" being only in a revenue account and balance sheet accounts makes even less sense than before.

- 4. 10/28 11 POs and invoices and checks/vouchers/payments for 31 copier/equipment leasing expenditures, many of which can be printed directly from eFinance, Supposedly these will require 10.75 hours to produce, at a total cost of \$398.12 (\$45.50/hr.) That is preposterous, and we will pursue these records in Phase 2. I have already pointed out to you we were provided much larger batches of similar records easily and for free.
- 5. Your estimates for our 11/04, 11/06, 11/16, 11/18, 11/19 (Mazyck emails modification) and 11/20 PIA requests will be delayed past 10 days, and your responses past 30. That is preposterous, and we will pursue these records in Phase 2.

After that 7/08 mess of a records pickup with School Safety Specialist Larry Titus, where he actually wore a State Police shirt in a pathetic attempt at intimidation, we decided to accelerate our requests. There has been hardly a single request to which you have replied honestly, fairly, and in full. On 10/14 I told you "it would be a bad idea to pretend our reasonable inundation of records requests is anything less than warranted," so you went whining to the Md. AG's Public Access Ombudsman's office. You (and others) have committed serious financial crimes, and know their exposure will expose you to proof of other abuses. Even if abuse is hard to prove, financial crimes are not, and as you continue to decompensate, we continue to put together a more comprehensive picture of serious financial malfeasance.
