CCPS' 1:37pm response to 6/02 emails request, "interpreted" our request to be run through 0365 instead of clearly requested Gaggle, refuse to search both DNS-suffix addresses, offers emails in .PST format, product offered on flash drive or email, attempt to claim inability to comply with request, "encompasses large volume of materials," IT Dir. McClellan, IT Program Coord. Joel Parmer both involved, supposedly Parmer had to become "familiar" with software he has understood since ~2014, total cost \$109.83-\$250.20, supposedly ~162 "responsive documents;" staff, instead of paralegal, "identified" for redaction

• Mon., Our response to ridiculous fees and obfuscation for email records, IT Director McClellan stated in 2018 searches have to be performed in Gaggle to cover full date range, we ask to waive requirement to pay in advance to reduce number of trips to Central Office for COVID and inconvenience, still will not accept piecemeal responses, fee breakdown doesn't make sense.

• Wed., CCPS sends REVISED cost estimate to 5/17 PIA financials request, after the 1st 5/28 estimate we disputed. Says \$121.02 for 6 years of all fund ledgers, \$91.20 for 3 bid files for bidder privacy consultation, surveillance POs and supporting docs \$814.80, after 2 hours waived instead of \$350 total cost is \$859.12. No more \$175/hr. paralegal redaction. Flash drive not requested (we asked for records via email) is \$10.

Thurs., Curry continues to set up RC Karen Maxey, fees make no sense and rife with contradictions, vendor data for contractors entering schools must be known and transparent, IDIQ bid explanation; other surveillance bidders including P2 sound infinitely more responsible; lo and behold, surveillance contract POs and supporting docs DO exist; does CCPS keep organized records? Why isn't \$350 waived instead of 2 hrs.?

• Tues., Letter to Curry asking if we may pick up records alone in board meeting room like we did on 7/26/18, to protect against Coronavirus concerns, or we're willing to pass records and payment through the front doors to Central Office and review them on the steps

- •8:22pm Letter to Curry (scum) re: pickup difficulties, Safety Specialist Larry Titus wearing State Police Camp Cops shirt, visitor allowed in while we weren't; Titus - Let's hope we [CCPS] are using proper fingerprinting policy/standards or maybe we're hiring people we shouldn't be; paid for records in protest, without review, Titus claimed he has no knowledge of our situation and no job is worth compromising his character, initial observations of records when downloaded at home (untaping of envelopes and downloads of flash drives recorded); are all surveillance POs included?; only 117 disorganized emails provided, no count sheets, student code names improperly redacted; included email helping prove campaign against Sarah, thousands of emails (including duplicates) missing, email addresses missing, emails cost 2.5x more per than 4/30/18 emails, the remainder for which we sued, \$350 should have been waived from both requests, instead of only 2 hours; informing new financial PIA request coming; gearing up for Phase 2

We've already received some of these Vendor ledgers in Phase 1 of our PIA suit and none could be withheld then.
