County Commissioners,

On October 30th I sent you a letter in which I eviscerated your joke of a proposed performance audit for CCPS and called out current Commissioners Buddy Hance and Mike Hart, and former Commissioners Kelly McConkey and Steve Weems, for conspiring to destroy me, to try to prevent me from forcing the truth about a pedophile ring and obtaining records which prove serious financial crimes have been committed in CCPS. Two days later, you informed CCPS your joint meeting to discuss the proposed shell of a performance audit was cancelled. As far as I know it has not been rescheduled. The intent of my letter was not for you to shut down the audit; rather, I hoped you would reconsider the proposed categories so there might be an expanded and *legitimate* performance audit. Although Buddy Hance claimed the results of an audit would be shared with the public for “transparency,” this is even less transparent than before, and only more of your coverup.

As I explained to you in my October 30th letter, an actual, full performance audit would expose crimes committed in CCPS, including some Hart, Hance, Weems and McConkey were in on and/or tried to cover up. This includes how CCPS actually funded and supplied former Sheriff Mike Evans’ drug ring, after he extorted various forms of insurance from former Superintendent and sadistic pedophile Daniel D. Curry, in exchange for looking the other way on children being molested in the system. I also mentioned the \$3 million dollars the Commission knowingly funded to pay my pedophile former therapist, Richard Kelly, to destroy me, to try to keep me from receiving financial records for which I was suing, and from continuing to tell the truth, effectively putting out a hit on me. Given Hart, Hance, Weems and McConkey were content to *knowingly* conspire and coordinate with pedophiles, grifters, drug dealers and rumored murderers, it does beg the question as to what’s wrong with them. Regardless, Mike Hart and Buddy Hance should resign in shame and Kelly McConkey should drop his bid for the BoE, after he lost reelection to the Commission. Interestingly, my former therapist Richard Kelly alluded to Kelly McConkey having something to do with his own drug dealing, dirty cop, polygraph-failing son, Luis Kelly. I know why McConkey voted to renew former Superintendent Daniel D. Curry’s contract way back in 2017, even though he knew Curry is a sadistic monster, back when McConkey was on the BoE. McConkey was never good enough for the BoE or the Commission. Why was McConkey effusive in his praise of sadistic pedophile Daniel D. Curry and former Sheriff and drug dealer Mike Evans?

What I haven’t so far mentioned is that the Commission knowingly funded *another* \$3 million to CCPS to try to make me go away. I sued for email and financial records from CCPS in 2019 and 2020. In September of 2019 we had our first pretrial conference, which as I mentioned in the last letter, I could not attend due to then-severe left side brain deficiencies. After my attorney was accused of conspiring

and sleeping with me (not even remotely true) I was offered \$3 million to go away. But I didn't take the money – I took the records. I got what I wanted, knowing that if I received the records, I could piece together a picture of financial crimes which would help bring in law enforcement to address the pedophile ring in CCPS. Back then I didn't know Evans is a drug dealer; I only thought he had his own problems with addiction. I had no idea I would receive records which would prove payments to a mail-away prescription insurance provider which supplied Evans' drug ring and excessive payments to Blue Cross/Blue Shield to compensate the medical providers for prescribing. My suit for records concluded in Spring of 2020, resulting in what might be the most successful records suit in state history, after I was awarded 90% of legal costs. Unfortunately, CCPS did not provide all the records I should have received, but could not prove back then; however, I received quite a bit and have received more records since.

Although Mike Evans', the Commission's and CCPS' conspiracy with my pathologically lying, grifting, sadistic pedophile former therapist Richard Kelly failed, and the \$3 million offered to me didn't go anywhere, that wasn't the end of things. They got worse. The Commission, Daniel D. Curry, Mike Evans, Richard Kelly, other medical providers, and scum like local criminal underbelly attorneys were still plotting my destruction. Richard Kelly continued manipulating and brainwashing me through November of 2019, which took a long time afterward for me to process and overcome. He also recorded our sessions and other people listened to them. I don't know if any Commissioners did, but I suspect it. Therefore, they know what I said, and most of it wasn't even remotely close to what Richard Kelly and others have claimed about me. It smacks of the desperation you and others felt that you would continue to conspire with Richard Kelly, after he failed so miserably in making me go away for over a year. The one Commissioner who wasn't in on all of this? Former Commissioner Tim Hutchins, who resigned right before the last meeting of the 20-21 fiscal year, when the following fiscal year's budget was to be approved. Why did he choose to resign at that particular time? I don't know everything, but I know some things. I don't believe he could stomach dealing with the other four loser Commissioners. He has ethics and principles. Tim Hutchins really *cares*. He also had had enough of the conspiracy to try to destroy me. At that point in time there was another plot in the works – this time for the Commission to pay *family* of mine, who live in Oregon. Tim Hutchins would not vote for it in the FY21-22 budget.

Mike Evans, Hart, Hance, Weems, McConkey and others were *still* conspiring with sicko Richard Kelly to destroy me, along with all the others. You see, I'm one of those people who doesn't come from a nice family, of which Richard Kelly was aware, and which he and the others decided to exploit. The family from which I come is generally bright, capable and of means – but they are also mostly evil, with no fundamental sense of integrity. There is no reason for them to do what they do, but they do it anyway. For example, our mother tried to kill my kids on the anniversary of my dad's death, which should give an idea of what she did to him. I loved him, had put together some of the pieces and was starting to talk, among other things. I was long gone by the time our mother died, but my impressively accomplished, golden child, lying, grifting, fraudster, sadistic sister - who also hated our mother, but only for selfish reasons - conveniently was there, her motives having to do with money and personal revenge, to which I could never relate. Somehow, even though everybody and their brother knew our mother wanted to be buried, it was in every iteration of will our mother ever had and my sister and I had discussed it years prior, my sister chose to violate our mother's last wishes and had her cremated so fast it was nearly spontaneous, later feigning ignorance as to our mother's wishes. This was conveniently right after my sister's unscrupulous Chapter 7 was finally discharged, after first being dismissed. And I know a *lot* more than that. Extended family on that side is no better, and nearly down to a man, also evil. So, what did the broad-spanning Calvert consortium of evil and corruption decide to do? Conspire with my cousin in

Oregon, to abuse, lie about and manipulate me. I used to mostly trust her – now I know she’s as bad as the rest. I don’t know how much she was paid or if any other family of mine, like my sister who Richard Kelly pronounced a sociopath (I firmly agree) were paid. But that is part of why honorable and decent Tim Hutchins chose to resign.

Now I’m going to enumerate some other facts in this situation:

1. Calvert County has a human trafficking problem, which extends into a pedophile ring in Calvert County Schools. Some of these children are procured through the schools for abuse by many outside of the schools. Calvert County is by no means unique in this respect. There are other counties/districts in Maryland who had/have sadistic pedophile superintendents, and even those that don’t still have these problems in upper and lower administrations. Furthermore, this is well-networked around the country and part of a much larger human trafficking problem. As the internet has exploded, it’s only made things easier for pedophiles to network and firm their entrenchment in American public schools and systems. Moreover, there are pedophile policy makers who create policies at federal, state and local levels, which are designed to promote chaos and abuse in the school systems. These policies reduce and eliminate consequences for bad behavior; a hallmark of pedophilic educational policy. That’s why the public schools are so much worse than they were several years ago.
2. None of my children, who used to attend CCPS until they were in danger and no longer safe to remain in the system, because my daughter was documenting what was going on at Southern Middle School and we were complaining, were sexually abused. A slew of malicious educators plotted and schemed to destroy my daughter for documenting what was really going on and to keep me from complaining. Southern Middle has been used as a dumping ground for some of the worst in the system. After we removed my daughter my eldest son, at Calvert High, was next, back when creepy slimebag Steve Lucas was Principal and Anthony Barone was an Assistant Principal. Both of them were *very* friendly with Daniel D. Curry, and they progressed unusually fast in their careers under his “leadership.” Fortunately, we removed all our kids before any of them were further hurt. My daughter’s abusers at Southern Middle still have jobs around the system, like Travis Mister, Ashley Adams and Rachel Baker. They should all have been terminated, long ago. Instead, they were protected and even rewarded.
3. The boy at Southern Middle who was terrorizing my daughter and others was actually screaming out for help. He was being molested by then-SMS Assistant Principal Travis Mister, which was discovered in Spring 2018 by CCPS administrators, due to my complaints. Travis Mister has been protected since, first being transferred to Plum Point Middle for a year, and has been Assistant Principal at the CTA at Calvert High ever since. Drug dealing Mike Evans, sadistic pedophile Daniel D. Curry and the BoE protected Travis Mister. This includes evil former BoE members Tracy McGuire, Bill Phalen and Kelly McConkey, as well as evil current member Dawn Balinski. The boy’s parents were never contacted, and that poor young man ended up at Calvert High where Mister was transferred. He is now an adult. The Commission has known all of these things for years.
4. There was no effort made to look for other victims of Mister’s - of whom there may be many - as Mister was at Southern Middle for years. Mike Evans and Daniel D. Curry wouldn’t allow it, but Evans did use the situation as an opportunity to extort yet more insurance benefits from then-Superintendent Daniel D. Curry – all at taxpayer expense, of course. Meantime, Mister still has a job and pretends he is not the evil bully and pedophile he is. Conversely, sadistic pedophile Daniel D. Curry made a habit of serially penalizing, tormenting and even *torturing* decent educators, which the complicit Board also supported. Mister has a habit of mistreating decent educators, as well. Most pedophiles are misogynists and sadists. Former therapist Richard Kelly

even smugly told me there is usually one in administration at many schools in CCPS, which was one of the slighter instances where he flaunted that he molests teenage girls. Richard Kelly loves to get his panties in a wad over abortion, but threw away his own children, molests other children and knowingly conspired and coordinated with pedophiles, including Curry, whose primary/favorite predilection is for *newborns*, although he also molests boys older than that.

5. *Numerous* Calvert County (and some beyond) medical providers have prescribed for former Sheriff Mike Evans' drug ring. When this blows, Calvert County's medical community will be decimated. Providers who will do what they do should be in no helping profession and belong in prison. It will be a point of personal pleasure for me to see them exposed and going away, after what some of them have done to me and what I know they have done to so many others. These providers pretend to be pillars of the community. Regardless, the community will suffer.
6. Other medical providers who are not supposed to prescribe (like Richard Kelly and Yvonne Micheli) also received free CCPS health insurance. I don't know why, but there are plenty of them all over this county. They too pretend to be pillars of the community.
7. My life has been in danger and I have been in dirty cops' sights for a long time. It's been less than pleasant. I firmly believe the main reason I am still alive is because of the good cops aware of this situation. We should all be grateful for our new sheriff and his administration, after the dregs who preceded them.
8. Mike Evans had Sheriff's Office personnel stalk me. I was regularly followed under his regime. I don't know what they were hoping to find. Daniel D. Curry liked to stalk people too, and would check out CCPS vans to go sit in front of the homes of families whose children had been abused and were complaining.
9. CCPS paid \$38 million in two years and two months for the mail-away prescription pill insurance that supplied the drug ring, which Mike Evans extorted from former CCPS pedophile Superintendent Daniel D. Curry, to look the other way on children being molested. I don't know how much it cost, in addition, for the extorted group health/prescription insurance, to compensate these medical providers for their crimes in prescribing. It heartens me to think of the stress these evil providers have felt, like former orthopedist Debra Spatz. The lying, abusive monster actually fled her practice, unannounced, due to this situation, and I am very eager to see her held accountable.
10. Mike Evans controls the mail in Calvert County. We are not the only family who dealt with egregious mail tampering – theft, envelopes and packages rifled through, items in packages swapped in an attempt to threaten and intimidate, etc. Just as Evans controls the mail, he also received his prescription drugs through the mail.
11. The day after the first pretrial conference for records, former BoE member Tracy McGuire fled the Board meeting and Dawn Balinski announced *for her* that McGuire would not be running again, ostensibly due to term limits, which did not exist. Tracy McGuire's husband has since retired from his "data processing" role in the IT department. Why *did* McGuire flee and choose not to run again, right after my attorney denied an inappropriate relationship with me and I didn't take the money? Those financial records scared her, and badly. I wish I had received all the records I should have. McGuire was never good enough for the Board, nor to run for reelection, but at least she lost this last time.
12. CCPS has hidden slush funds, or at least that's how former Superintendent Daniel D. Curry used them. From what I've seen I don't think they are being used that way under Dr. Townsel. These ledgers are held separate in CCPS' eFinance system, and transactions from them do not reflect in vendor history reports or expenditure reports, like some of the million plus paid on a rigged bid for surveillance installation. Although the IDIQ (Indefinite Delivery/Indefinite Quantity) bid was supposed to be around \$35k, a pedophile, Andrew Gerber, was awarded the contract,

escorted through the schools by then-CCPS School Safety Specialist Larry Titus and paid *many* times more than that; then he was allowed to select another firm to continue his work. They were never vetted, whatsoever. You can find the charges to which Andrew Gerber pled guilty in the Maryland Judiciary Case Search. St. Mary's County Schools also hired Gerber to install surveillance, back when Michael Martirano was superintendent down there. Until very recently Martirano was superintendent of Howard County Schools. Michael Martirano also worked in Montgomery County, and was state superintendent of West Virginia schools. His wife was found in the water in Solomons several years back. Water washes away evidence. Former Sheriff Mike Evans was on scene and pronounced her death a suicide, but the manner of death was never disclosed, nor was there made mention of a note or toxicology. Drowning is an unusual way to commit suicide.

13. Richard Kelly said I said horrible things about my children I never came close to thinking, saying or feeling. It caused a great deal of pain. He kept comparing me to his daughter-in-law - whose cooking he detests - and telling banal stories about himself, his wife and other character-deficient individuals, which he then later attributed to me. Back then I had no idea what laid behind Richard Kelly and his wife's relationship; these supposedly decent, abortion-fighting Catholics. Although he claimed to have loved her, individuals like Richard Kelly are not capable of love, and she was only a part of his façade.
14. I am not "demented," and despite my left-side brain deficiencies have always known what I know and don't know. I did my own work, independent of anyone else.
15. I have been slut-shamed for years, with outrageous claims made that I slept with my records suit attorney, sleep around in general and am a prostitute – all preposterous and untrue. Men were even approaching me, and while none of them were too untoward, I do wonder if it wasn't hoped I would be assaulted.

Commissioners Grasso, Cox and Ireland, you now know enough that if you don't do the right thing and call in law enforcement, you too will be complicit and deserving of exposure and consequences. It's not for nothing County Attorney John Norris noticeably blanched when I mentioned the term "executive sessions" to him. I know you know. Invite in law enforcement in order to expedite their investigations, so people can start receiving the help they need as soon as possible, and others can be exposed, stopped and held responsible. You three make a majority – do the right thing.

You need to think about something. What I am talking about is enough to destroy Calvert County's bond rating. Calvert County does not deserve its AAA bond rating, but that has nothing to do with the majority of staff at the County and CCPS levels – it's a leadership problem. All it would take would be to contact Moody's, Barron's, Standard and Poor's, and of course, Fitch, to tell them what I know, and I am prepared to do it. Clifton Larsen Allen audits both the County and CCPS. Below is an excerpt from a December 16, 2019 letter where I break down a December 12, 2019 report by CLA to CCPS. They very clearly intimate that CCPS is not "low risk," but in fact "other than low risk," which only means "high risk."

"We watched the most recent Board meeting and the Auditor's Report was ALARMING. There were three auditors from Clifton Larson Allen present, alongside CFO Edith Hutchins. Their presentation was little more than a disclaimer acknowledging how insufficient their audits have been. Why aren't there any audits on the CCPS website since 2016? How comprehensive were those audits?

Among the statements:

- Mr. Walker (chief auditor?) indicated his retirement was timely
- Cumulative contracts/leases, such as for "copiers," are apparently a big deal

- Audits were based on “assumptions”
- “4-6 pages” – maybe for the isolated single audit? How is that sufficient?! If that audit pertained only to the \$9.4 million in federal finding CCPS received, what about the other ~\$200-210 million in the budget? To what audit/s were they speaking?
- Mentioned no other auditors were consulted – “would have been incumbent to disclose”
- “All you would have to do is say it wasn’t there”
- “didn’t discuss any issues prior to engagement”
- Go by standards and do not give an opinion
- “If you didn’t put it in the statements it wouldn’t change our opinion”
- Mr. Walker/CLA’s statements are an “opinion” and “everything else is a representation of {CCPS} management.”
- Everything else, for “Edie,” “she can answer them”
- “figure you meet the threshold” for the “low-risk” auditee status
- For “high risk” ... “the amount of work goes up exponentially”
- “figured high risk was too negative,” therefore, the title for high risk is “other than low risk.”
- 20% was the auditing threshold based on “low risk” standards; again, for only a limited amount of CCPS funding?
- “everything else” was in “bucket C” and not audited
- “Looked at Child Nutrition cluster” and “Striving Readers Comprehensive Literacy Program,” but, “doesn’t mean we looked at every expenditure in the programs.”
- “Sampled...looked at certain items”
- Material weakness – “we’re not allowed to say certain things” ... “we found no material weaknesses”
- Looking at “operating statement” ...” general fund” ...”Student Activity Fund.”
- Ms. McGuire mentioned specifically the “Student Activity Fund.”
- Might put Student Activity Fund into the General Fund, *or* a “Special Revenue Fund.”
- Among the general items of note for improvement – staff leaving the system should have their access removed immediately. One individual (he) who resigned in March was still in the system and had access as of June 30th.

Look at my results so far. Former Sheriff Mike Evans chose not to run, in good part because of my efforts. Former Superintendent Daniel D. Curry is gone because of me. His pedophile/procurer wife, Jacqueline Wisnauskas, who taught 1st grade at Patuxent Appeal Elementary, has been terminated. Numerous other personnel have left CCPS, either by choice or force, because of my efforts, including, unfortunately, some good employees who were abused, compromised and/or pressured. Spineless, cowardly, pathetic, milquetoast weasel Steve Weems’ vestiges of conscience caused him not to run for the Commission again. Although Dr. Susan Johnson was my favorite for the Superintendent role to replace Curry, this time CCPS didn’t go through their usual pedophile procurement channel (Maryland Association of Boards of Education), and employed a responsible recruiting firm so that Dr. Andrae Townsel is the new Superintendent – a *tremendous* improvement from his predecessor. But for good employees who were abused and pressured to do things they knew weren’t right, resulting in their resignations, premature retirements and terminations, I am proud of all these things. All I have to do is tell the truth, and while it sickens me to think the taxpayers will have to pay higher costs to borrow because of your malfeasance, it is you (and your predecessors) who have brought the County to this point. As Mike Hart burst out at a joint meeting with CCPS on September 9, 2021 - “THE BOND RATING!” Clearly, the bond rating matters more to him than all the children he has known for so many

years must have been molested and people's lives being destroyed by drugs at taxpayer expense, just like he likes to blivate on and on about the cost of HVAC systems for CCPS buildings, as if he really believes that's one of the biggest problems in CCPS. Mike Hart has repeatedly and clearly demonstrated he cares more about scoring points than what most matters.

Don't get me wrong. I want and deserve money – a lot of it. After the many millions paid and all the other efforts undertaken to destroy me over these past several years it is only right. Every aspect of top local government leadership – Calvert County, CCPS and the Sheriff's Office - have done their level best to destroy me and make me go away. They conspired with evil, badly compromised medical providers of mine, other individuals from Calvert County's seedy underworld and narcissistic/sociopathic family of mine. However, I refused to take money at the expense of children being molested, and Mike Evans' drug ring ended up being inextricably tied to the pedophile ring.

Among others, I am copying CCPS Superintendent Dr. Townsel on this letter, with the hope and expectation he will move to address things which predate his tenure, and for which he could be blamed, no matter how little he had to do with any of it. Dr. Townsel deserves all the help and support he can get. You knew it was going on for years, and did nothing, except conspire to try to destroy me and cover it up.

Mike Hart and Buddy Hance, I am again calling for your resignations, and www.ccountymd.com has been updated.
