Dear Dr. Townsel and BoE,

I'm sure most of you, if not all, know former Superintendent Daniel D. Curry is a sadistic pedophile. He wasn't even CCPS' first, which is why CCPS finally used a responsible recruiting firm, instead of pedophile-procuring conduit MABE (Maryland Association of Boards of Education), which helped ensure Dr. Townsel became superintendent. As in so many places, Calvert County has a pedophile ring, which extends into CCPS. While pedophiles are often attracted to employment in education and cannot always be known in order to be ferreted out, I assure you at least the majority of the Board has known there is a pedophile ring in CCPS for several years.

Although by then the Board knew enough about who and what Curry is, and the myriad ways he had already violated his contract, they chose to renew his contract, unanimously, for another four years. Then, at least a sufficient number of members allowed him to finish his last four-year contract, and he was supported in his abuses, crimes and cruelty across his eight-year tenure. The loser BoE members who protected him include – at the very least - Dawn Balinski, Tracy McGuire (terrified of my suit for financial records), Kelly McConkey (also later as a Commissioner) and Bill Phalen (deceased). Of course, these current and former members have always pretended to be caring pillars of the community; however, for what they have done they are anything but. For what they have known and what they covered up I don't see how they don't deserve to be held accountable, just like the pedophiles they have protected and for the terrible financial crimes they have tried to conceal, and in which some even participated. One can hope.

Aside from being a child sexual predator who used his position to molest young boys (even newborn babies), Daniel D. Curry also committed numerous financial crimes during his tenure, including blowing scores of millions of dollars of taxpayer funds to protect himself and his interests, as well as other child sexual predators'. The County Commission has increasingly known these things over the last many years and until more recently, most Commissioners were content to allow, facilitate and even finance a coverup with taxpayer dollars. The same is true of former Sheriff and drug dealer Mike Evans. But finally, after all these years, Calvert County has a capable, competent Sheriff who cares, as well as the three more recent members of the County

Commission, making for a responsible Commission majority. And then there is you, Dr. Townsel, a vast improvement over your predecessors, as well as BoE members Smith-Post and Grenis.

My kids left CCPS in 2018, after none of them were safe to remain in the system because Daniel D. Curry, other pedophile “educators” and a slew of malicious mean girl “educators” decided to stop my daughter and silence me. A plethora of these “educators” at Southern Middle plotted and schemed against my daughter, set her up and tried to drive her to a breakdown or suicide, merely because she was documenting the truth about circumstances at the school and her father and I were complaining. Then, when we removed her for her own safety, my sons at different schools were next on the list. None of these monsters were held accountable in any way, although if CCPS needs to reduce staff due to budget limitations they should be some of the first to go, and should have *all* been terminated long since. Although there are certainly some decent educators at Southern Middle, it has long been a dumping ground for some of the worst in the system.

I assure you the last three State’s Attorneys have all known about what happened to my kids, the pedophile ring, the drug ring, financial crimes and more, but so far have acted on nothing, not even State’s Attorney Robert Harvey, who has been in his role for over four years now. While it was nice to recently hear about a middle schooler who suffered anti-Semitic abuse being helped by the State’s Attorney, what happened to that poor child (and which should have been addressed by CCPS) absolutely pales in comparison to what happened and would have happened to my children and certainly to children who have been molested by child sexual predators in the system. The incongruity is striking and by this point one must wonder why no action has been taken. Meantime, the statute of limitations continues to expire on any number of crimes.

I have no idea why the State’s Attorney has yet to act on any of these, or so many other things he has known, including six-plus years of sometimes serious and even life-threatening attempts to destroy me for my efforts and what I know. This includes, but is by *no means* limited to, a conspiracy between some in CCPS and the Commission, as well as former Sheriff Mike Evans, to pay my former therapist Richard Kelly \$3 million (of taxpayer funds) to try to drive me to a breakdown or suicide, while setting me up to be charged with stealing from my son’s Cub Scout Pack. As an aside, many of them did this knowing Richard Kelly’s son, Luis Kelly, is a dirty cop in Evans’ ring, and Richard Kelly received free insurance and turns out to be a child sexual predator himself. When the setup failed and it was determined that everything was well-documented and I had even been generous, he then tried to brainwash me, and is only one medical monster responsible for violating confidentiality, spreading horrible lies about me in the community, and hurting and endangering me in a *number* of other ways.

Moreover, CCPS, in conspiracy with the same Commissioners and former Sheriff, offered *me* \$3 million, if only I would sign an NDA, leave this situation behind and not pursue the financial records for which I was then suing. I took the records, which helped to prove payments for Express Scripts mail-away prescription insurance, as well as a rigged bid with a pedophile surveillance installer, Andrew Gerber, of now-defunct G Technologies, who also installed cameras in St. Mary’s County Schools. However, the financial crimes are certainly not limited

only to those. And my own local government, including dirty, drug-dealing cops who still have jobs - in coordination and conjunction with other monsters like sleazy local criminal underbelly attorneys and numerous evil medical providers - has since then conspired in plenty of other ways to try to destroy me, to keep me from telling the truth about what I know, even going so far as to plot and scheme with evil family of mine, as far away as Oregon. And I have been through far more than that. I am not making this up and have been through absolute hell pursuing this situation.

Recently I was disgusted and dismayed to see you *promoted* known child sexual predator Travis Mister to Supervisor of Transportation, after he was first made known to the Board, law enforcement *and* State's Attorney in Spring of 2018 for molesting a prepubescent boy at Southern Middle. In February I copied all of you on a letter where I enumerated some of Mister's history, but members Balinski (who actively protected him), Claggett and White had already long known. Prior to his four-year stint at Southern he taught for years elsewhere in the district, before he was promoted by Daniel D. Curry to Assistant Principal at Southern, the most dangerous and violent middle school in the county. Not incidentally, Southern housed both a BDP (Behavioral Development) program and CCPS' only middle school Alternative Education program. Curry knew Mister is a pedophile when he appointed him. Then, after Mister was discovered through a CCPS investigation - based on our complaints - to have molested at least one young man at Southern, he was protectively transferred to Plum Point Middle, the other BDP middle school in the county. He spent one year there before being transferred to the CTA at Calvert High, and he also oversaw yet another alternative education program while there. Mike Evans and Daniel D. Curry did their best to prevent *any* investigation from occurring and would not allow further investigation to look for other potential victims, of whom there may be many. For so many years Mister has been around students with the most needs, and the easiest to exploit.

The boy he is known to have molested went to Calvert High where Mister had been transferred, and his parents were *never informed their son was molested*; however, the boy was blamed for his bad behavior, much of which may have resulted from his victimization and cries for help. He is now an adult and the community was never informed, either. One of the tactics Travis Mister employed to frighten, manipulate and control this boy he was molesting? He accused my daughter and other well-behaved kids of bullying the boy, who was actually terrorizing them, so the boy felt he could rely only on Mister for protection. Mister even actively encouraged and rewarded the poor boy's bad behavior, too. And now, Mister has been promoted to the Central Office. It's interesting Daniel D. Curry's pedophile/procurer wife, Jacqueline Wisnauskas, was terminated from Patuxent Appeal Elementary upon Curry's departure, but Mister was not. These things did not happen in a vacuum, and Curry, Wisnauskas and Mister are certainly are not the only networked pedophiles in CCPS who are also part of the broader pedophile ring.

Former Sheriff and drug dealer Mike Evans was aware of crimes being committed against children in the system at least as early as 2017, but instead of doing the right thing, used those crimes to extort, at the very least, health and prescription pill insurance from Daniel D. Curry, at considerable taxpayer expense. For example, CCPS paid around forty million dollars in two

years and two months for Express Scripts mail-away prescription insurance and the middlemen who facilitated it, even though CCPS employees continued to receive their excellent BCBS prescription insurance as always and needed no more coverage. They could have used the ~\$300 per month, per person, in plenty of other ways. Some of this Express Scripts mail-away prescription insurance was provided to CCPS employees as concealment, but the majority of what it cost (including for “premium shortfalls”) supplied Mike Evans’ drug ring and fed Calvert County’s opioid epidemic.

Evans also extorted Cadillac BCBS (Blue Cross/Blue Shield) health and prescription insurance from Curry, which was provided to medical providers all over the county and even beyond. I have no idea how many tens of millions that must have cost. Sometimes, premiums were paid from internal accounts which shouldn’t have been. This was done to compensate doctors and nurse practitioners for prescribing for Evans’ ring, but they are by no means the only medical providers who received free CCPS BCBS insurance. While I hope it’s not true, if my own experience is any indication, half or more of the doctors and nurse practitioners in this county may have received free insurance and prescribed for Evans’ ring, and that is why they have abused, manipulated and lied about me, maliciously and falsely diagnosed me, violated confidentiality, literally held me prisoner, drugged me against my will and without my knowledge, forcibly treated me after I had issued a written demand they have no more access to me, tried to get me to sign over power of attorney when I was half asleep, conspired with my own local government and others who fear exposure to destroy me and other awful, evil things. While neither ever suicide nor accident prone, I still very much fear being suicided or accidented, and am already not supposed to be alive. Still, I am glad about the county medical providers who *are* good at what they do, honest and ethical. Meantime, decent CCPS employees (the majority), like former teacher Jennifer Hudson, who has permanent brain damage due to Daniel D. Curry forcing her back to work against doctors’ orders and actually torturing her at the Central Office, assigning her tasks which targeted the part of her brain which was injured, lost her insurance, in violation of CCPS policy. Curry is nothing if not a sadist. The BoE, former Sheriff and others even knew he was trying to set up circumstances to encourage and cause a school shooting, and yet allowed him to continue in his depravity. Again, I am not making up these things.

Now, it is up to as many of you as possible to help right the wrongs of previous superintendents, uncaring and worthless current and former BoE members, current and former Commissioners of the same ilk, the former Sheriff and so many others. Unfortunately, prior superintendents, some current and former BoE members and so many more did their best to turn CCPS into a criminal organization. It is my hope there are enough responsible BoE members who will support this necessary and long overdue endeavor, and I believe you all will receive as much hope and help as possible from the Sheriff and majority of the Commission. After this letter you can’t say you didn’t know, and if you don’t do the right thing, all of you will be complicit and deserving of consequences, aside from Dawn Balinski, who already very much is. This is a politics aside, common good situation.

Toward that end, I am requesting you terminate Travis Mister from all employment and involvement with CCPS. I can only imagine how demoralizing it is for those employed by the system who know who and what Travis Mister is, how he bullied and plotted and schemed against educators and students alike, to see his promotion and know a child sexual predator has long enjoyed more completely unjustifiable protections and advancement than they ever could. Along those lines, and for those who still may not know what happened, I am copying every CCPS department director and supervisor on this letter, among others. If any other child sexual predators have been knowingly protected in the system, they should be immediately terminated, too, referred to law enforcement and the community informed.

Since the budget is tight, one way to possibly offset budget cuts and difficulties would be to identify each and every individual who shouldn't have received free insurance and pursue many of them for what they illegally and fraudulently received. That does exclude retired CCSO personnel, who also were provided BCBS insurance, which, at the time, they were not supposed to receive but now legally do. I doubt they had any idea their insurance was illegally provided and came at the expense of children being molested. There are probably other exceptions, too. All who received insurance who knew they shouldn't have deserve to be made known, and prosecuted where warranted. So many owe CCPS for what they knew they should not have received. While not all were part of the drug ring, and surely the majority of even those didn't know for so long the drug ring was supplied and financed by a pedophile ring coverup (they've known for years by now), many were more than content to contribute to the destruction of lives by adding to the opioid epidemic. In fact, many are so selfish and evil they would rather the pedophile and drug rings never be exposed, if only they can protect themselves from exposure. Also, it would be a good idea to ensure no one is still receiving free insurance who shouldn't. And, anyone and everyone who has been paid by my own local government to try to destroy me should be pursued for *full* remuneration, although I still don't know if these monsters were paid by CCPS or the County.

It will be very important to make clear the pedophile ring is highly networked and exists pretty much everywhere, and is by no means a reflection of the county and its people as a whole. But, as awful and evil as things have been, this is also an opportunity for improvement and change. I am convinced this nightmare situation has the capacity - if properly addressed - to motivate serious educational policy change, even at the federal level. While some well-intended but misguided policy makers have been part of developing and promulgating policies, at both state and federal levels, which have in turn brought our public education systems to their knees, plenty are pedophiles who know that chaos and abuse facilitate their sick, sadistic goals. For example, limiting and removing consequences for bad behavior in the schools is a hallmark of pedophilic educational policy.

Travis Mister is a pedophile who acts on his urges. Travis Mister is a bully. Travis Mister is a liar, schemer and cheat. Travis Mister should have been addressed years ago, and the community should have *long since* been informed. At least he's no longer in direct contact with children, but he should no more be privy to student transportation needs and schedules than he ever should have been permitted to remain anywhere in CCPS after he was exposed. Travis

Mister needs to go, and after all these years of abuses, it is incumbent upon you to do what your current and former colleagues, predecessors and others haven't, because they haven't cared and are, for one reason or another, involved in this disgusting criminal conspiracy.

I hope you'll do the right thing.
